

## Privacy Notice – Care Quality Commission

<b>Plain English explanation</b>	
<p>The Care Quality Commission (CQC) is an organisation established in English law by the Health and Social Care Act. The CQC is the regulator for English health and social care services to ensure that safe care is provided. They inspect and produce reports on all English general practice activities in a rolling 5 year program. <b>4) Lawful basis</b> for processing	<p>The legal basis is:</p> <p>Article 6(1)(c) “processing is necessary for compliance with a legal obligation to which the controller is subject.”</p> <p>And for Special Category Data</p> <p>Article 9(2)(h) “processing is necessary for the purposes of preventive or occupational medicine, for the assessment of the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or the management of health or social care systems and services on the basis of Union or Member State law or pursuant to contract with a health professional and subject to the conditions and safeguards referred to in paragraph 3;”</p>
<b>5) Recipient or categories of recipients</b> of the shared data	The data will be shared with the Care Quality Commission, its officers and staff and members of the inspection teams that visit us from time to time.
<b>6) Rights to object</b>	You have the right to object to some or all of the information being shared. Please contact our Data Protection Officer.
